Becker Exam Review Sweepstakes

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: Open only to legal residents of the fifty (50) United States and the District of Columbia, who have reached the age of 18 or the age of majority in his or her respective state. Void where prohibited. Employees (and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether related or not) of Becker Professional Education ("Sponsor"), and their respective parents, affiliates, subsidiaries and advertising and promotion agencies are not eligible to enter to win.
